- d. For documents exceeding 1,000 words, the Client and Alliance Française shall reach an agreement on the delivery date of the translation.
- e. Upon signing this agreement, the client shall pay 50% of the estimated cost. The balance shall be paid upon release of the translated documents.
- f. Payment of the contract price shall not be subject to the prior acceptance of work.
- g. Alliance Française de Manille (AFM) is not liable for any loss of documents submitted for translation.
- h. The Client's signature below implies that the Client agrees to the AFM Operational Translation Policy. Please ask the AFM agent regarding the said policy. "ESTIMATED" means the pages and the cost may be lesser or higher after translation.
- i. Though under the expedite option, the discretion of the final Release Date belongs to the translator alone.
